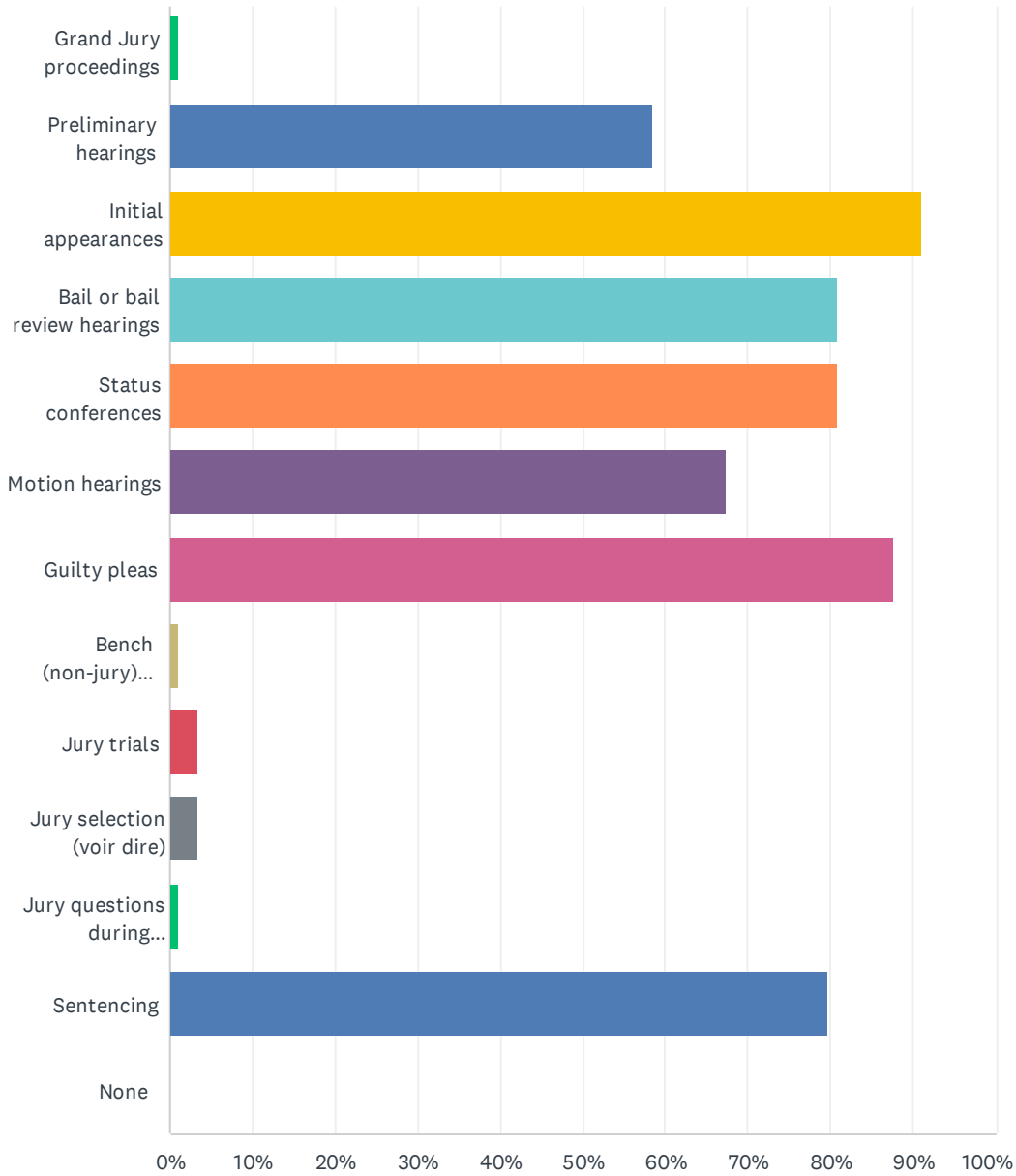


Q1 Which type of criminal proceedings have you been involved with while using remote video technology? (Select all that apply)

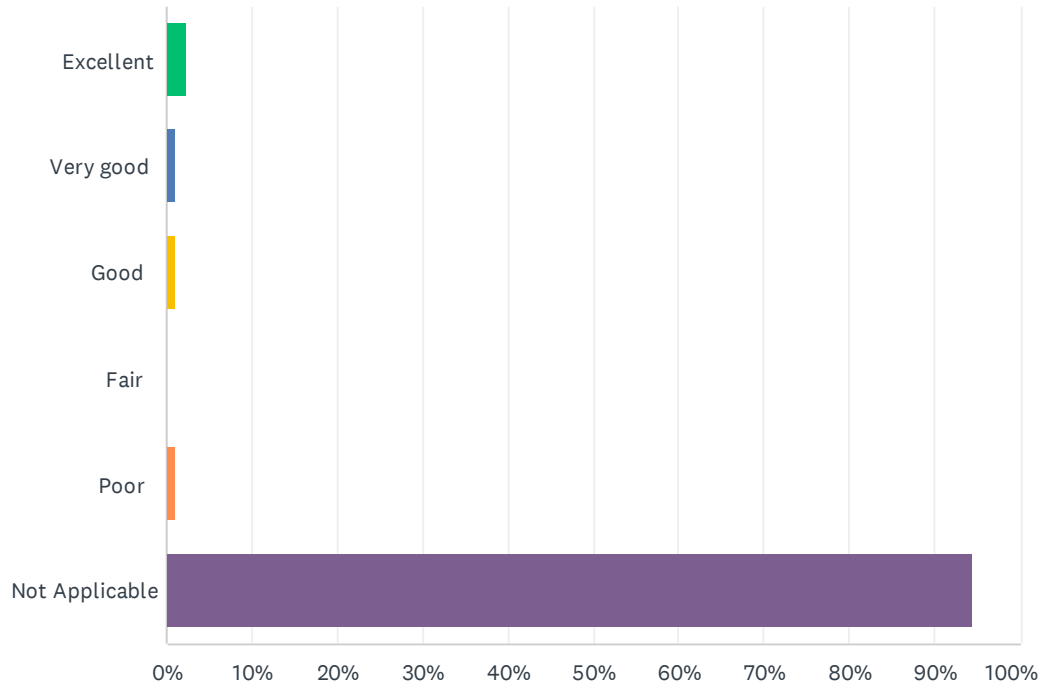

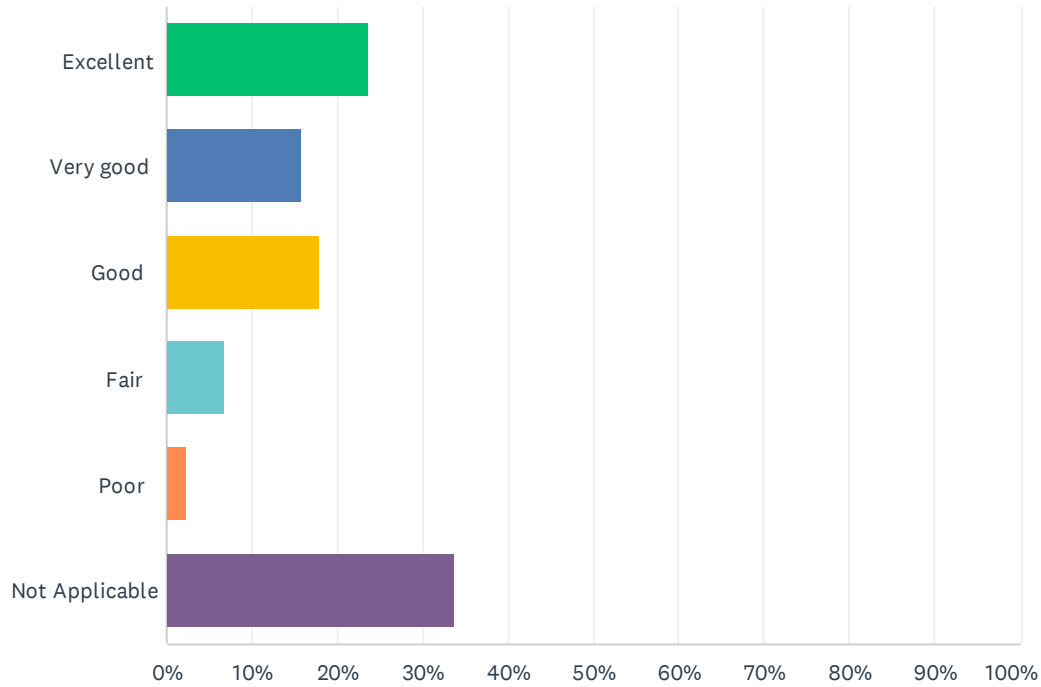

Q3 Indicate the quality of preliminary hearings in which you have been involved that included the use of remote video technology.

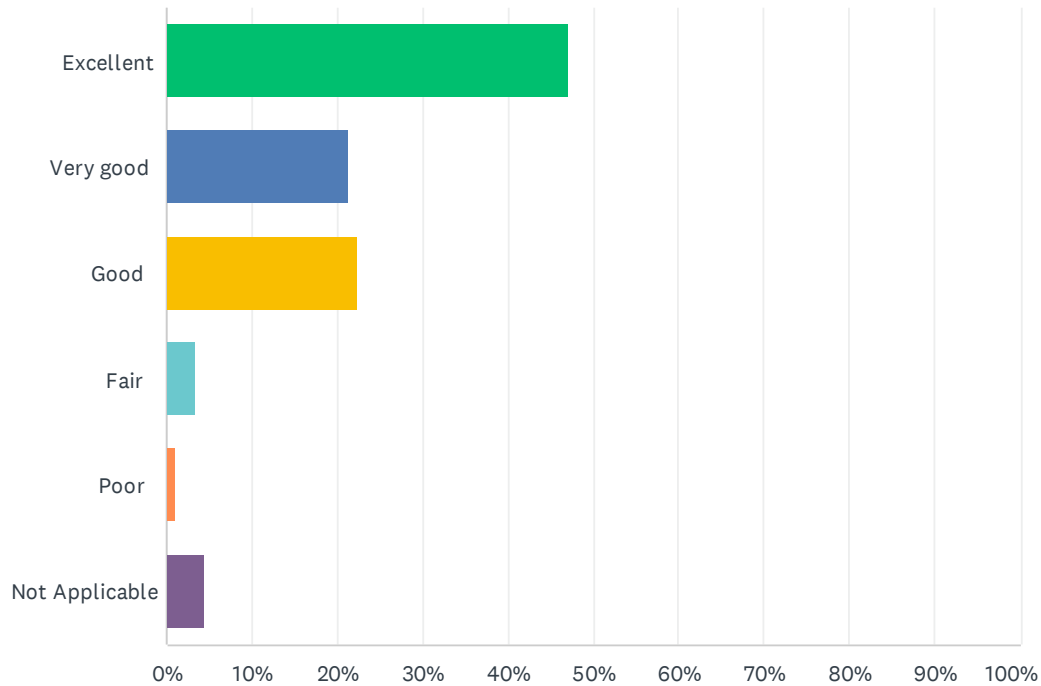

Q4 Indicate the quality of initial appearances involving entry of plea or otherwise in which you have been involved that included the use of remote video technology.

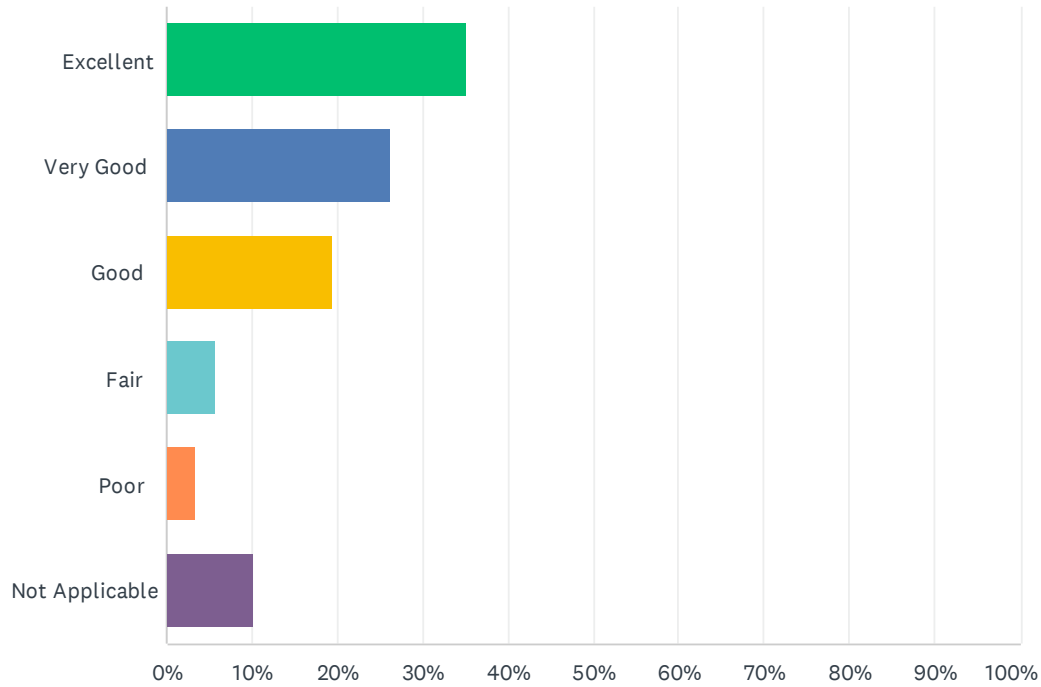

Q5 Indicate the quality of bail or bail review hearings in which you have been involved that included the use of remote video technology.

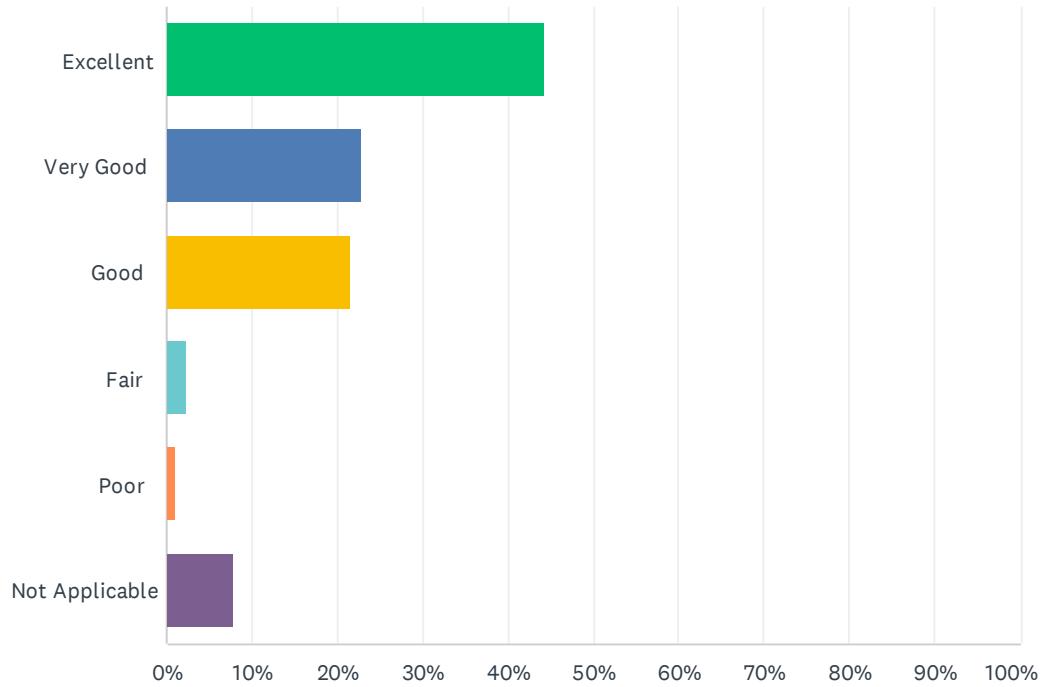

Q6 Indicate the quality of status conferences in which you have been involved that included the use of remote video technology.

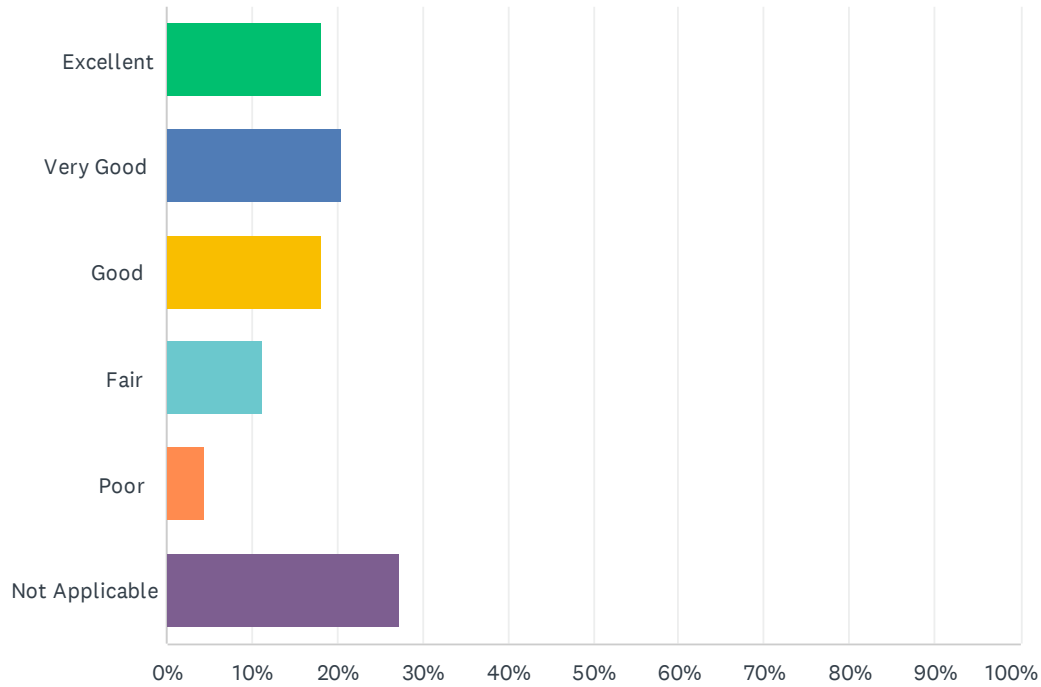

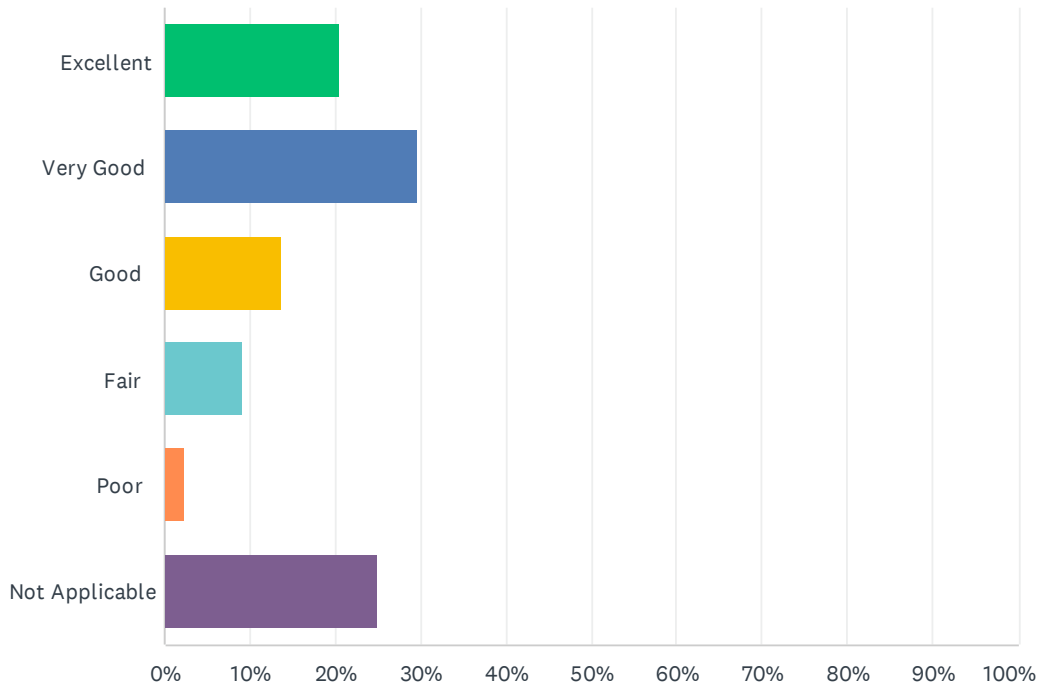

Q8 Indicate the quality of motion hearings not involving live testimony in which you have been involved that included the use of remote video technology.

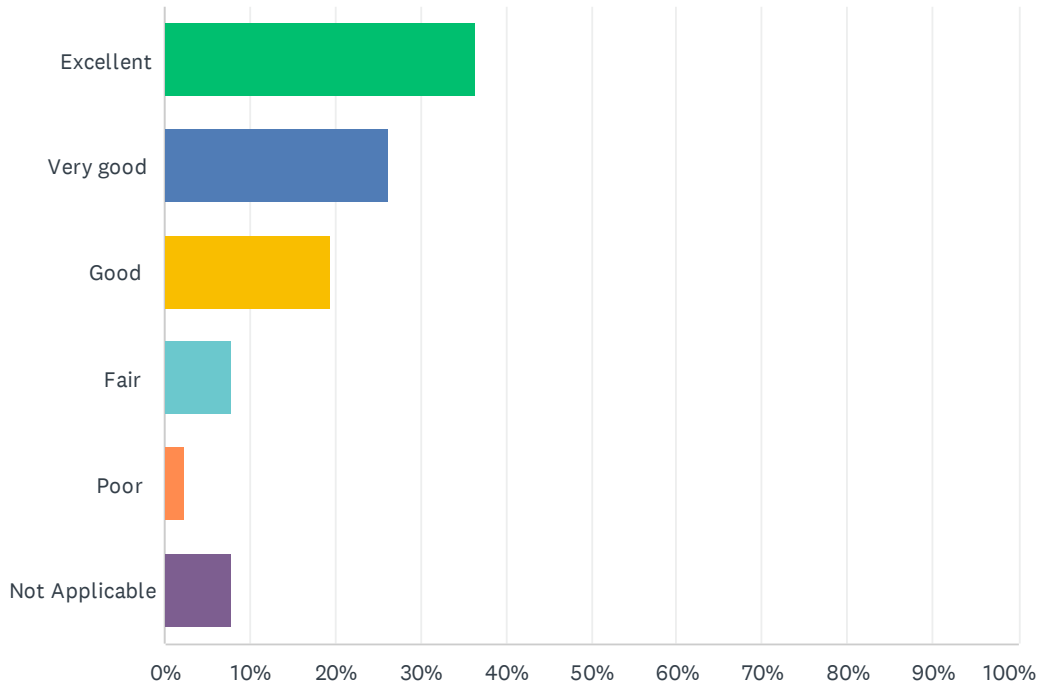

Q9 Indicate the quality of guilty plea proceedings which you have been involved that included the use of remote video technology.

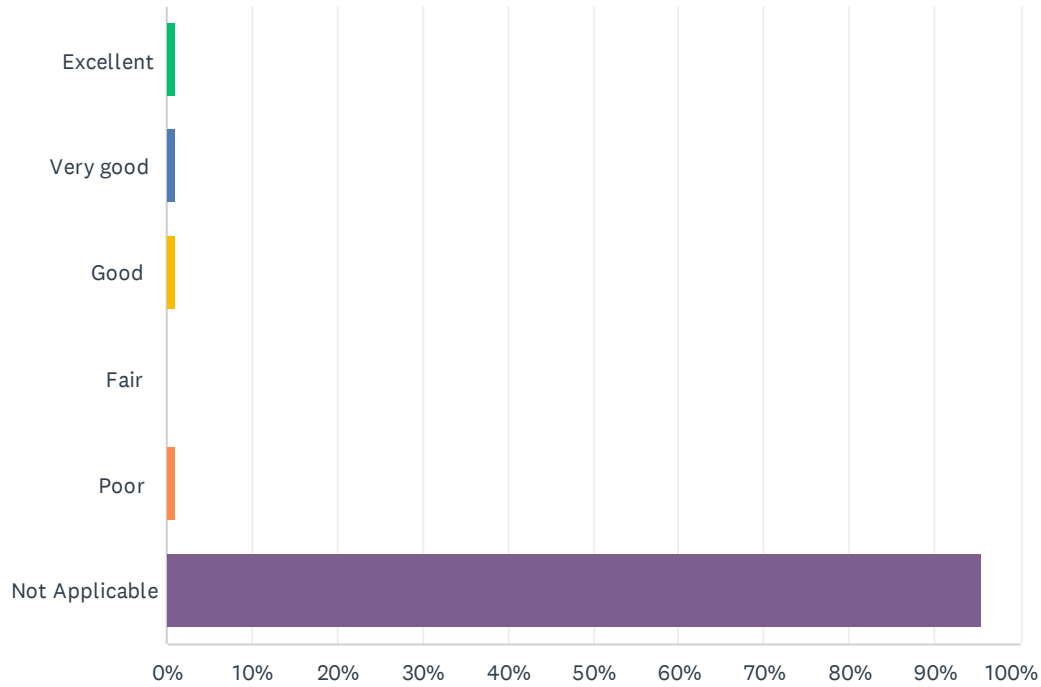

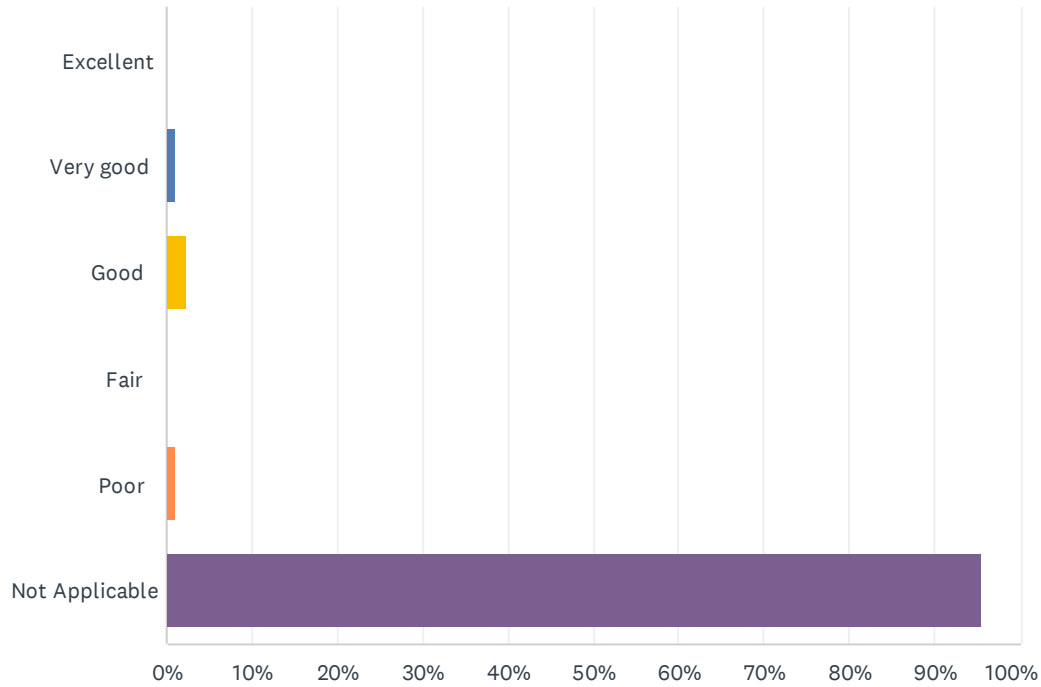

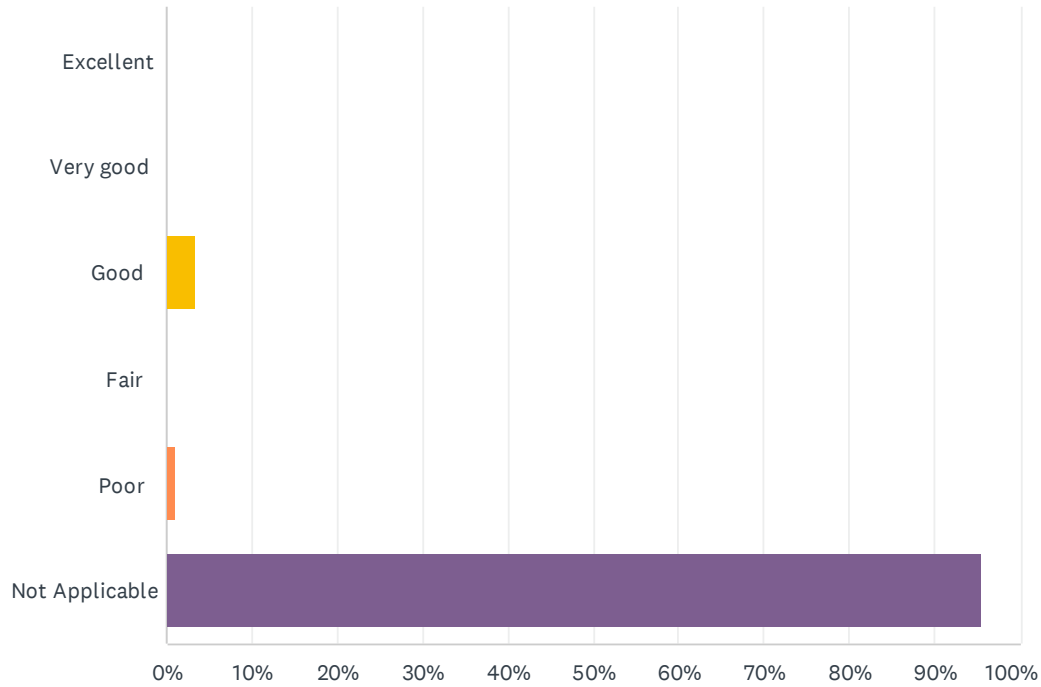

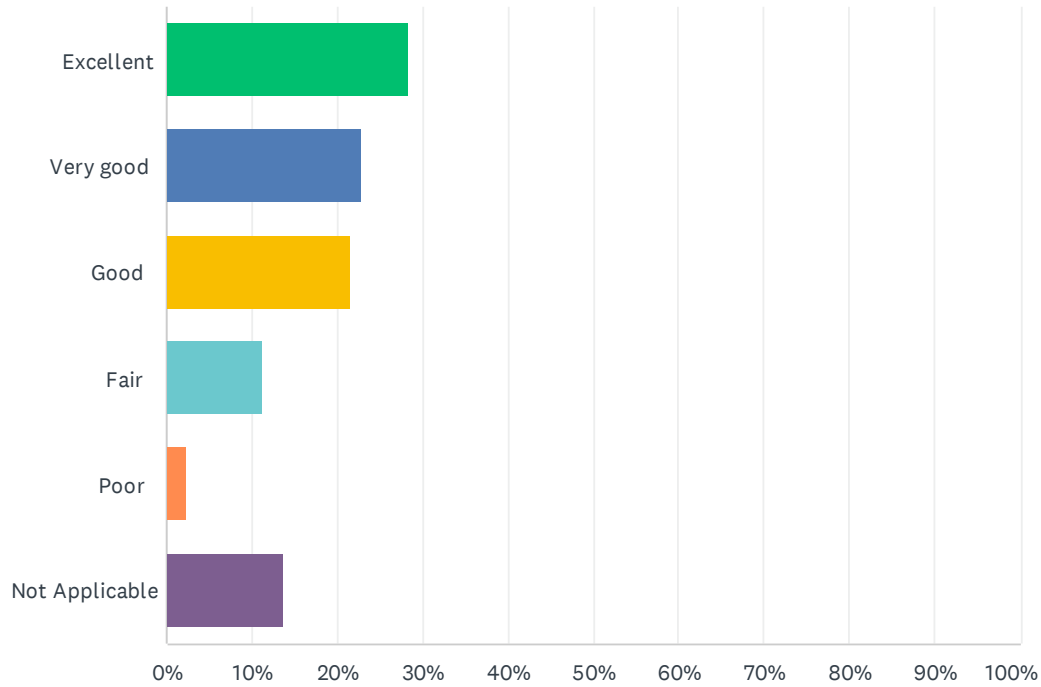

Q13 Indicate the quality of sentencing hearings in which you have been involved that included the use of remote video technology.

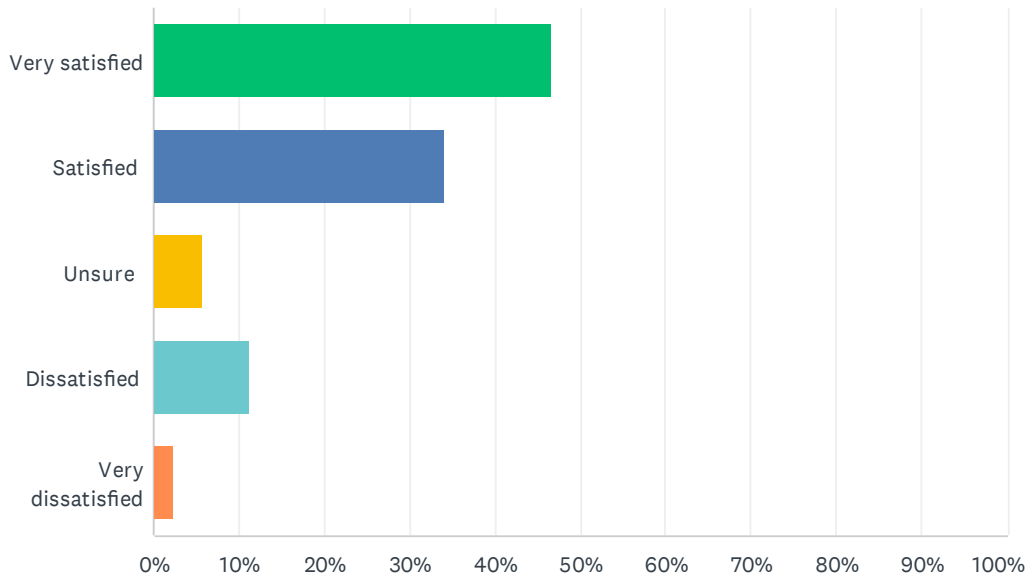

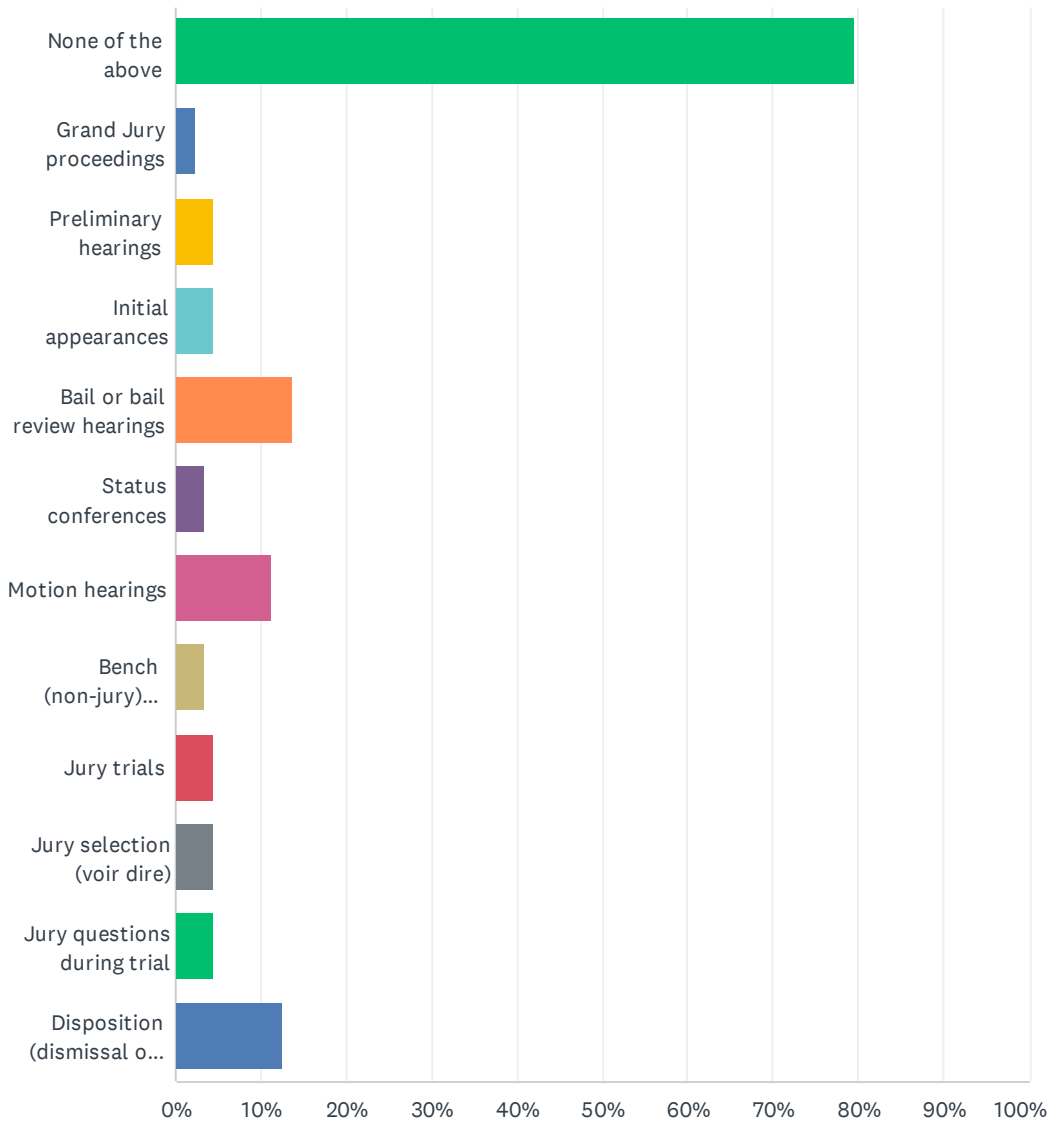

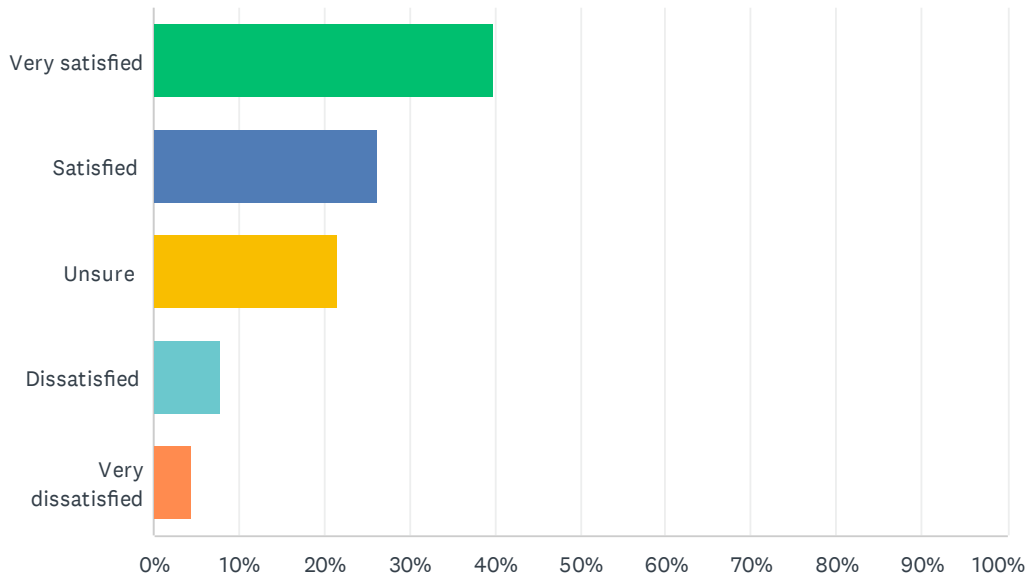

Q16 How satisfied are you that the use of remote video technology to conduct court proceedings promotes public trust and confidence in the courts?

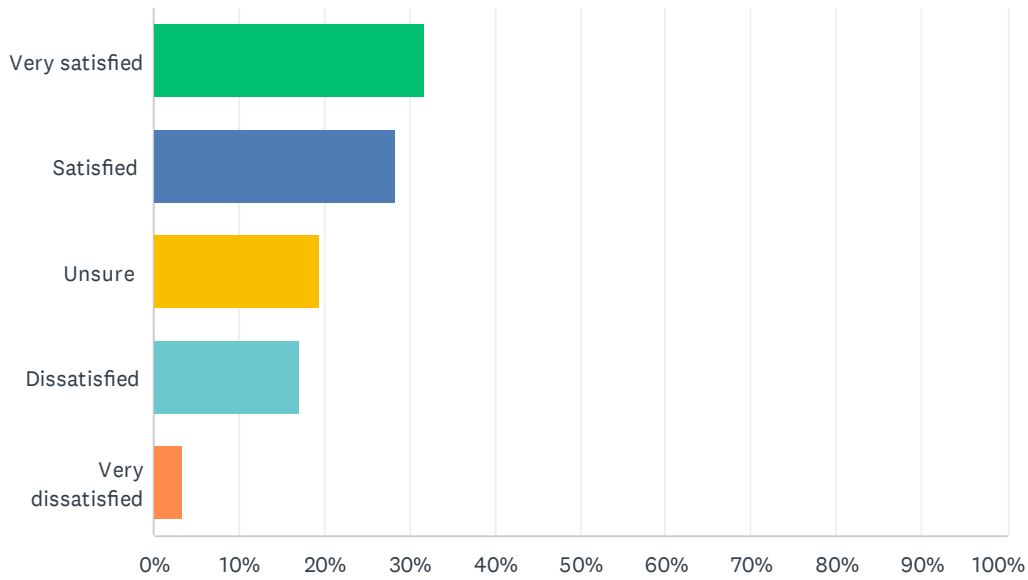

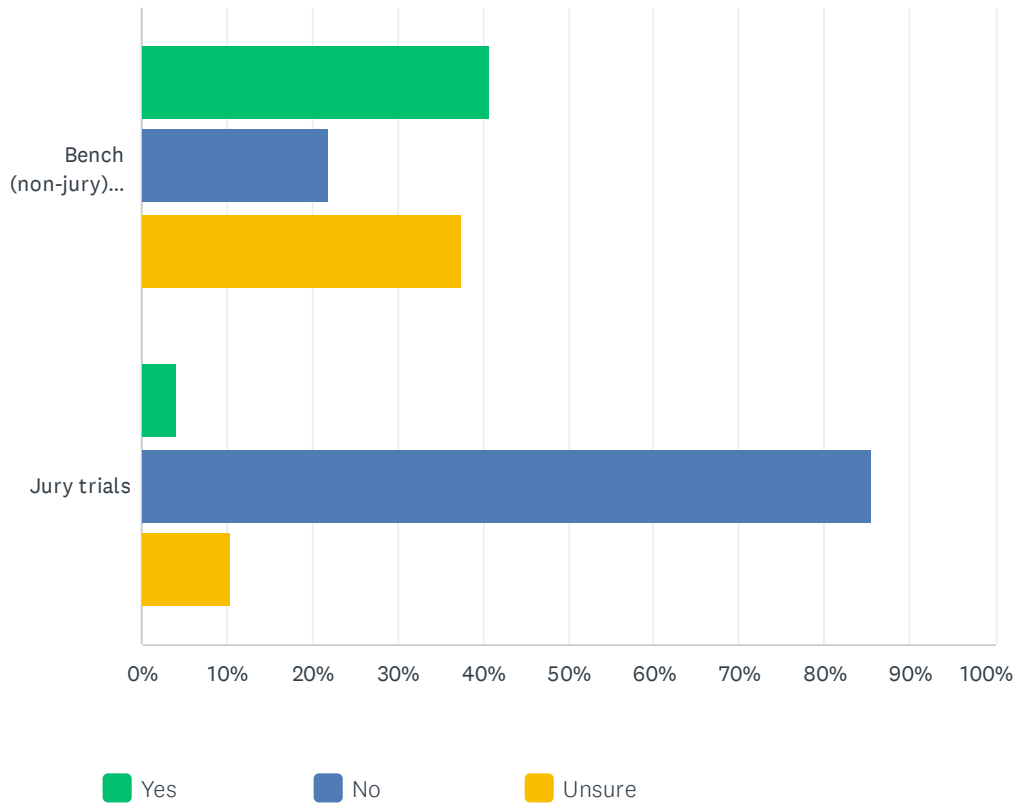

Q18 Do you believe the court system should continue to incorporate the use of remote technology in the following types of criminal court proceedings even after the end of the COVID-19 pandemic?

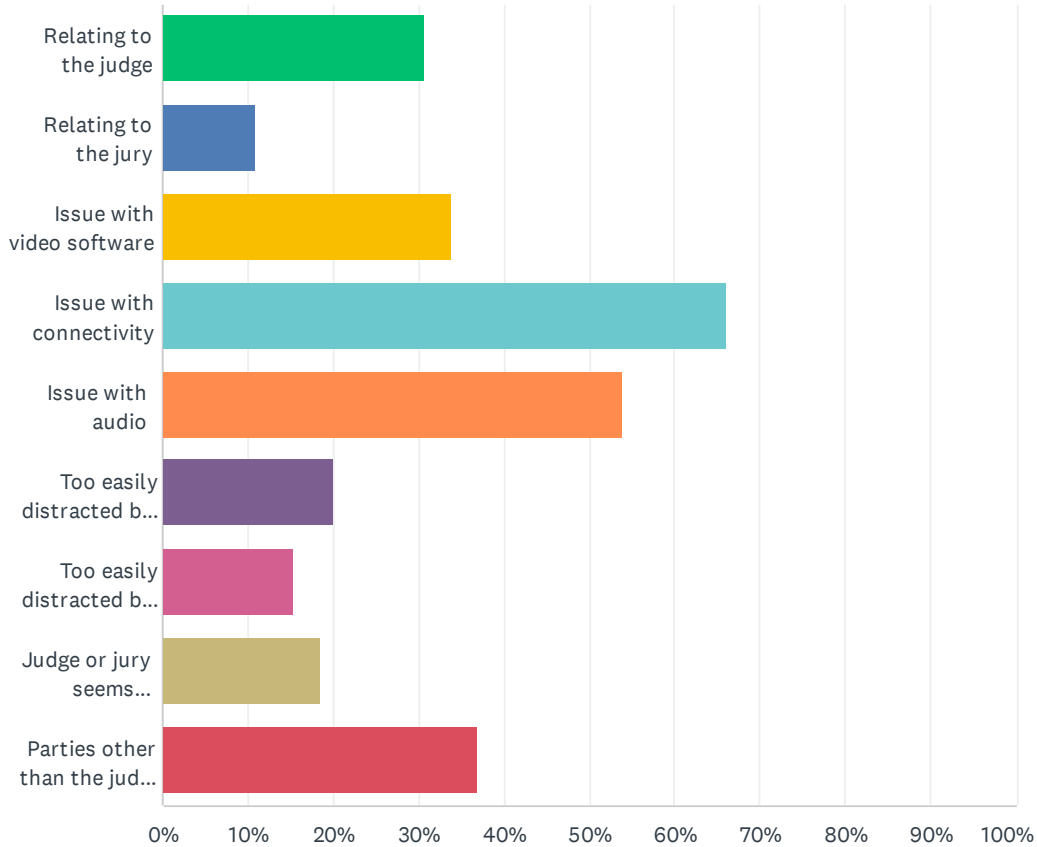
